Caretaker

We have said farewell, with all good wishes, to caretaker Alex Kelberman, who chose to leave with the change of agents.

We are in the process of recruiting a new caretaker, and will have temporary cover for the next few weeks. The new caretaker will be employed by Landform, the company which carries out the maintenance of the gardens, and the hope is that, as part of the same company, the new caretaker will form a close working relationship with the gardeners Alan and Mark, whose positions have not been affected by the change of agent.

Of course, unlike Georgian England we have to accommodate cars and boiler flues and keep up with ever-changing technology, so we do try to exercise some flexibility.

But generally, we will do everything we can to protect the look of the estate and enforce covenants in the interests of all of us – and we need your support in that.

You will have received a copy of the covenants when you bought your property. Guidance is also included in the new handbook. Bartholomews will be reviewing any covenant breaches as part of their implementation of the new contract and will be contacting owners to correct these.
